C. RN21-031 – Lab System Queue Selector & AAC - \$37,740.70

Motion to approve a piece of equipment to test in the lab that has the ability to handle automatic callback for abandoned calls and a form of call tree capability was made by Chief Spivey and seconded by Rick Brunson. Motion passed unanimously.

EVERMAN/TARRANT COUNTY FIRE ALARM CONSOLIDATION (RN21-033)

Craig Spencer, Everman City Manager & Chief of Public Safety, presented the consolidation of Everman PSAP and Tarrant County Fire Alarm. The City of Everman was going to contribute the original estimated total project cost of \$95,000. The communications construction cost has increased from \$35,000 to \$120,000. The electrical work cost is still TBD, estimated at \$30,000, will not know the exact cost until the MEP plans are sent out to bid. The Tarrant County Fire Alarm Board can cover \$45,000 of the costs. The City of Everman is asking for up to \$50,000 in assistance to support the project.

Motion to approve the use of PSAP Assistance funds to provide up to \$50,000 to support the City of Everman and Tarrant County Fire Alarm Consolidation project was made by Chief Spivey and seconded by Aubry Insco. Mayor Richardson abstained from voting. Motion passed 6-0-1.

NETWORK REDESIGN AT&T LETTERS OF AGREEMENT FOR CONSTRUCTION SERVICES REVIEW

Kevin Kleck presented letters of agreement for constructions services at four locations for the network redesign.

INTERIM EXECUTIVE DIRECTOR REPORT

BRIEFINGS

Legislative Update – Bill Paxton, The Eppstein Group, reported he recently participated in a meeting regarding HB 2911 to discuss the implementation and timeline of the fund. In the fall, the Governor is expected to call the legislature back to divide the funds the state is supposed to receive from the federal government. The Governor's Office has to request the funds from the federal government. Once the funds are received, the legislature then determines how the monies will be allocated, including the money going into the NG911 fund. The Comptroller's office is working on rules to establish the NG911 fund, and we will get a draft before the final draft is released. There will be a 60-day comment period on the final draft. The Comptroller's rule will work by establishing the fund then transferring it to CSEC to administer. CSEC is drafting a mechanism on how the funds will be allocated to the 9-1-1 districts around the state. They are working on a cost template to send the districts to list the costs needed to implement NG911.

9-1-1 SERVICE FEE RESOLUTION (RN21-032)

Wireline Fee Resolution for signatures. The service fee rates were approved at the July 19 board meeting.

FY 2022 BUDGET

Motion to approve the FY 2022 budget was made by Aubry Insco and seconded by Assistant Chief Swearingin. Motion passed unanimously.
